Energy Healing is the application of Energy Medicine modalities individually or in combination. Energy Medicine and Healing is intended to complement and not replace any prescribed medical care. I am not a medical professional or psychologist and do not diagnose conditions or prescribe treatment.

My goal as an energy healer and practitioner is to facilitate your innate healing ability through the use of **Healing Remembered, Belief Breakthrough, the Emotion Code, Body Code and Belief Code**, to discover the root, cause and/or contributing factors of the issue. I am then able to release and resolve the energetic imbalances and facilitate healing. These modalities are comprehensive and complex databases of imbalances and energies, and methods to identify, release and resolve them.

Quantum healing is a multidimensional approach to wellness that addresses the root cause of imbalances by working with the body, mind, and spirit at an energetic level. It goes beyond traditional methods by tapping into the quantum field, where all possibilities exist, to release deeply held traumas, emotional blocks, and energetic patterns. By accessing this field, quantum healing facilitates profound shifts, restoring balance, harmony, and alignment within oneself. It empowers a person to heal not just the symptoms but the underlying imprints that shape their experiences.
